## 1 INTRODUCTION

### 1.1 ABOUT THIS MANUAL

This document can be read in conjunction with the message format spreadsheet. The spreadsheet contains all the required information for each Buna MX message.

### 1.3 STATUSES OF THE FIELDS IN THE MESSAGE DESCRIPTIONS

A field in the message format descriptions may be either optional (status "O") or mandatory (status "M").

"OA" means optional field with alternative mapping to MX.

"MA" means mandatory field with alternative mapping to MX.

"C" means conditional line of a field; the line can be present if upper line is present in the message.

### 1.4 LIST OF SYMBOLS ALLOWED FOR POINTING IN BUNA IPS MESSAGES

The allowed symbols/characters are defined by ISO format for each MX tag.



For example, MX tags in Max35Text format allow using Arabic symbols and it is defined for fields Name and Address. In case of any message formats conversion Arabic symbols will be replaced with dots.

## 1.5 DAY AND TIME FORMAT IN STATUS MESSAGE

ISO Date/time format with time zone is used both in a <Document> tag and in an Application Header.

Each transfer is uniquely identified by the following group of fields:

- Participant's BIC/Pseudo-BIC, identifying the sender of transfer (Instructing Agent of MX message);
- Transaction Reference Number (<MsgId> in <GrpHdr> of MX message);
- Value Date (<IntrBkStlMdt> in MX message).
- Instruction reference (<InstrId> in MX message) to identify a transaction inside a batch.




*Figure 1. Rejection by IPS*


Figure 2. Rejection of counterparty processed in IPS.






Figure 5. Single customer credit transfer with authorization (Local instrument SCYF-SCCT-AUTH):




*Figure 7. Single customer credit transfer with authorization (Local instrument SCYF-SCCT-AUTH):


Figure 8. Single customer credit transfer with authorization (Local instrument SCYF-SCCT-AUTH):


Figure 9. Single customer credit transfer with authorization (Local instrument SCYF-SCCT-AUTH): Decline by counterparty.


Figure 10. Single customer credit transfer with authorization (Local instrument SCYF-SCCT-AUTH): Authorization message is rejected by IPS before timeout.



Batch is a file multiple pacs.008 Inside. Each pacs.008 inside the file will be a single pacs.008 (not a batch).

Singe pacs.008s can have only the same Instructing Agent as other pacs.008 and different (from other pacs.008) Instructed Agents and currencies.








Figure 14. Refusal of counterparty failed in IPS.








Figure 18. Return transfer without authorization.

Figure 19. Return transfer based on request: rejection by IPS on receiving.








Figure 21. Return transfer without authorization: rejection by IPS on receiving.

Figure 22. Approval of counterparty failed in IPS.









*Figure 25. Notification of a new debit cap value.*






Figure 27. Setting/increasing/decreasing debit cap value by DP for PSP: successful flow.


